(i) Covid No Dey Show for Face: Interrogating Panic Pandemic and Social Stigmatisation in Selected Pandemic Narratives

Fear and social stigmatisation are two dominant reactions during pandemics, past and present, in fictional as well as factual representations. COVID-19 is the trouble of the moment, and the present pandemic, being an emergent one, calls for much scholarship and intellectual engagements. This study examines the representation of panic pandemic and social stigmatisation in Tony Marinho's *The Epidemic*, Deon Meyer's *Fever* and Véronique Tadjo's *In company of men*, three narratives that depict a pandemic caused by coronavirus and similar viruses. The narratives are critically analysed through Freudian psychoanalysis, with a view to broadening humanistic comprehension of the present pandemic. While the relationship between disease and social conditions have been erstwhile established, the research highlights the profound interconnections between disease and psychological states, thereby underscoring how fear-induced reactions are often indeed the pandemic behind the pandemic.

The project started in June, 2021 and it is to be completed by February 20, 2023.

(ii) Twice Disillusioned: Immigrant Suffering in Alain Mabanckou's *Blue White Red* and Fatou Diome's *The Belly of the Atlantic*

The representation of double disillusionment is fast becoming a defining characteristic feature of contemporary African migrant fiction. More often than not, African migrant characters are traumatised by the legacies of colonialism, underdevelopment and unemployment within the postcolony and even when they migrate to the so-called greener pastures, their fate hardly improves. Thus, African migrant characters are twice disillusioned and revictimized. In the West, many times African migrant characters face racism, homelessness, unhomeliness, police brutality and so on. The two purposively selected texts are analysed using the postcolonial theory.

The project started in August, 2021 and it is to be completed by March 31, 2023.
